NOTIFICATION

Dated Guwahati the 26th of July, 2023

No.GSA.02/2023/79: Whereas information was received from the Registrar, Bodoland University vide No.BU/CSHE/61/2023/771 dated 18.07.2023 regarding information about alleged arrest of Govt. employees by Directorate of Vigilance & Anti-Corruption and CM's Special Vigilance Cell, along with many enclosures.

And whereas attention of the Hon'ble Chancellor of Bodoland University was drawn vide letter Memo No. SVC/RI/CASE No. 01/2022/1810 dtd 24.07.2023 received from Superintendent of Police, Chief Minister's Special Vigilance Cell on the allegations raised against the Vice Chancellor, Bodoland University:

- (a) regarding alleged work order reportedly allotted without following standard norms,
 - (b) regarding alleged appointment of Finance Officer not in conformity to the guidelines and criteria as per the advertisement,
 - (c) regarding alleged drawal of full salary by one Assistant Professor who is under suspension and
 - (d) regarding alleged admission of student in PhD program without appearing in entrance examination
- and register of a Vigilance P.S. case No. 01/2022,

And whereas, Vice Chancellor, Bodoland University vide letter dated 21.07.2023 informed Hon'ble Governor about the matter along with many enclosures.

And whereas in view of the above, the Chancellor of Bodoland University, in exercise of the power conferred upon him under Sub-section (1) of Section 9 of Bodoland University Act., 2009 is pleased to constitute a High Level Enquiry Committee with the following members to enquire into the matter in detail and to ascertain the facts:

The Committee shall, during the enquiry, visit the Bodoland University premises, enquire such documents as it deems necessary, take copies, record statements, call for reports, conduct field inspections, may have discussion with any of the persons/organizations etc. in this connection etc.

The committee will submit report, after enquiry, within a period of thirty (30) days from the date of issue of this notification i.e. on or before 25th August, 2023.
